

Pick the 2018 World Cup Winner

OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Eligibility.** Contest open to U.S. residents (excluding Puerto Rico), 18 years or older at the time of entry.
3. **Entry.** The Pick the 2018 World Cup Winner (the "Contest") will begin at 12:01 a.m. PST on February 5, 2018 and ends at 11:59 p.m. PST on June 1, 2018 (the "Contest Period"). You must complete all requested information to participate. as well as identify your "Picks".

How to Make Your Picks: You may submit one Pick for the Winner of the Finals, and the Finalist. Also pick for tie breaker the Runner up (Consolation game) Winner and runner up. Entries that do not comply with this requirement will not be eligible to win. At the end of the World Cup 2018, the contestant(s) who has picked the winning team, and Finalist (subject to compliance with these Official Rules). In the event of a tie, the following tie-breaking procedure ("Tie-Breaking Procedure") will be used. Pick the winner of the Runner up game and then the loser of the Runner Up game.

If two or more contestants are stilled tied the final tie breaker will be the earliest entry time. If there is still a tie after the Tie-Breaking Procedure is completed, the remaining contestants will be entered into a random drawing to determine the Grand Prize winner.

Sponsor will not be responsible for incomplete, late, or misdirected entries or for failure to receive entries due to transmission failures or technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Sponsor. In the event of a dispute, all online entries will be deemed to have been submitted by the holder of the e-mail account identified at the time of entry. You must be a Team Coach or Manager of Record at the time of entry. All USSF affiliated teams are eligible. List of affiliated organizations will be provided in the entry form.

4. **Grand Prize and Odds** . One Grand Prize Winner will receive a Free entry to the 2018 Orange County Kick Off Classic 2018 provided by the Sponsor. The Grand Prize has a total approximate retail value of Cost of application entry depending on the age of the team. Odds of winning depend on the number of eligible entries received and the number of correct Picks each contestant submits.
5. **Winner Notification and Acceptance**. Winner will be notified by electronic mail on or about July 31, 2018. Return of prize notification as undeliverable may result in disqualification and an alternate winner may be selected. Winner may waive his/her right to receive prize. Prize is non assignable and non transferable. No substitutions allowed, except that prize is subject to availability, and Sponsor reserves the right to substitute prize of equal or greater value. Winner is solely responsible for reporting and payment of any taxes on prize. Winner may be required to complete an affidavit of eligibility, and a liability and publicity release (except where prohibited by law) which must be returned within ten (10) days of date of postmark. Failure to sign and return the affidavit or release within ten (10) days, or to comply with any term or condition of these Official Rules, may, at the sole discretion of Sponsor, result in the winner's disqualification, the forfeiture of his or her interest in the prize, and the award of prize to an alternate winner.
